#### NATIONAL HEADQUARTERS NEWS

The National ACEP Constitutional Convention will be held on November 7, 1972, preceding the Fourth Annual Scientific Assembly at the San Francisco Hilton, November 8–10. The general membership assembly will convene at 2:00 PM. If accepted, the new ACEP Constitution will provide for a representative Council to elect and provide direction to the Board of Directors, A copy of the proposed Constitution and Bylaws has been forwarded to the membership.

Members are encouraged to register early for the November Scientific Session in San Francisco.

### ORGANIZATIONAL MEETING IN MIAMI

An Ohio State Chapter organizational meeting was held during the ACEP Third Annual Scientific Session in Miami, Tuesday, October 12, 1971. A formal petition for chapter status had been submitted by the Ohio membership prior to this meeting. The suggested constitution and bylaws for state chapters of ACEP was approved. The ACEP Board of Directors subsequently approved our petition for chapter status.
