

## **Gregory L. Henry, MD, FACEP**

### ***Speaker Profile***

Gregory L. Henry, MD, FACEP, is an Emergency Physician on staff at multiple hospitals in the Ann Arbor, Michigan area. He is the former Chief of the Department of Emergency Medicine at Oakwood Hospital – Beyer Center in Ypsilanti, Michigan where he held the position for 21 years. Dr. Henry serves academically as Clinical Professor the Department of Emergency Medicine at the University of Michigan Medical School in Ann Arbor, Michigan.

Dr. Henry is the past President of the American College of Emergency Physicians. His Presidential year was from October 1995 to October 1996. The American College of Emergency Physicians (ACEP) is the principal professional society for approximately 35,000 emergency physicians across the United States. As a member of ACEP since 1976 and a member of its Board of Directors for 8 years, Dr. Henry has been involved in all aspects of emergency health care policy at the national level. At the Michigan affiliates of ACEP, the Michigan College of Emergency Physicians, Dr. Henry has held the positions of counselor and treasurer as well as a member of the Board of Directors. He has been extremely active with the Government Affairs Committee and serviced as Chairman of the Long Range Policy Committee. Dr. Henry has also been a representative for ACEP through the 'Brain Attack' working group at the National Institute of Health.

Dr. Henry as authored numerous articles and books throughout his career. Currently he is a consultant reviewer for five journals dealing with emergency medicine including the *Annals of Emergency Medicine*. He is on the Editorial Board for of the publication *ED Management* and has served on multiple other Editorial Boards. He is the author of multiple books on neurologic disease and risk management in emergency medicine as well as over 70 text book chapters and numerous articles on numerous aspects of emergency care.

Dr. Henry is a frequent lecturer on topics concerning health policy, risk management, neurologic disease and pain management. He has lectured at over 97 residency programs in emergency medicine and to over 180,000 emergency physicians at various meetings. He was the winner of the first ACEP outstanding speaker of the year award, 1998-1999. In addition to his ACEP affiliations, Dr. Henry is a member of the American Medical Association and has served as the emergency medicine representative to the specialty society medical liability project. Dr. Henry has sat on the Professional and Technical Advisory Committee of the Joint Commission on Accreditation of Healthcare Organizations. He is also a member of the Michigan State Medical Society, The Society of Academic Emergency Medicine and The Washtenaw County Medical Society. Dr. Henry received his undergraduate degree from the University of Michigan and his medical degree from the University of Michigan in 1973. Dr. Henry lives with his family in Ann Arbor, Michigan.

His contributions are legend and he is has a keen interest in improving patient care and risk management as well as neurologic disease. His expertise in the field of risk management is pre-eminent in the field. He has reviewed over 2,150 malpractice cases over the last 36 years and has served as a risk management consultant for numerous physician groups and hospitals throughout the United States. He is the former President and Managing Officer of two emergency medicine malpractice insurance companies. Teaching is his passion and his love for the field where risk medicine is reflected and energy and enthusiasm is brought to his presentations.
